國家科學及技術委員會(NSTC)與芬蘭科學院(AKA) 雙邊合作人員交流計畫

2023/06

國家科學及技術委員會(以下簡稱本會)與芬蘭科學院(Academy of Finland, AKA)為鼓勵臺灣與芬蘭雙方研究人員在各領域進行合作研究,於2021年重新洽簽科學合作協定,公開徵求臺芬雙邊人員交流計畫,以共同補助雙邊計畫內研究人員(需具博士學位者)之短期<u>交流互訪</u>之<u>2年期計畫</u>,每年以補助<u>3件</u>為原則。本會作業時程如下:

註:若因不可抗力因素、協議機構審查時間或雙邊會議時程延後等,本會得視情形調整公布審查結果時間,得不另行通知。

- 一、計畫主持人資格: 我方計畫主人須符合本會「補助專題研究計畫作業要點」 之計畫主持人資格。
- 二、計畫補助:我方每件計畫補助經費上限約為新臺幣 500,000 元/年,以補助進行交流計畫之國外差旅費用(不可為至第三國訪問之費用)。
 - (一) 補助模式:由派遣方負擔其團隊國際機票及生活費(A Type)。
 - (二)補助我方研究人員差旅費:
 - 1. <u>交通費</u>:臺灣與芬蘭最直接航程經濟艙等來回機票,臺灣及芬蘭境內 長途公共交通費。
 - 2. <u>生活費</u>:我方人員之生活費部份請參考行政院「中央各機關(含事業機構)派赴國外進修、研究、實習人員補助項目及數額表」之標準。
 - 3. <u>保險費</u>:請參考「因公赴國外出差或返國述職人員綜合保險費率表」, 採 400 萬保額之保險費標準編列綜合保險費,依實際旅途日期計算。
- 三、計畫審查:相關計畫申請案將由本會與芬方 AKA 兩方獨立進行學術審查, 復經雙方共同審議後評定暨擇優補助。其中本會審查重點項目包含①主持 人及其團隊研究表現②計畫內容之學術性③計畫內容之國際合作④經費補 助金額之妥適性。





四、申請程序:本項申請案須由臺、芬雙方計畫主持人分別向本會及協議單位 (AKA)同時提出申請,且雙方提出之計畫名稱須相同,內容須經雙方同 意,申請案始獲成立。其中,

 - (2) **I002A 國際合作研究計畫研究人員**:請新增申請補助臺方參與本計 畫之主持人/共同主持人或博士後出國交流訪問者。
 - (3) 002 雙邊/申請補助經費:只編列我方所需負擔費用。
 - (4) 新增申請案時,除須填具各項申請資訊欄位,並應同時將①臺芬交 流計畫英文申請表(如附件 template)、②雙方計畫主持人及參與訪 問的研究人員英文履歷及近五年著作目錄等各項文件以 PDF 檔上 傳至系統後送出。
- (二)計畫申請案須經主持人任職機構於系統中彙整後送出,依本會「國際合作類-雙邊國際合作與交流管理系統」線上彙整作業系統製作及列印申請名冊(由系統自動產生,並按計畫歸屬處別列印)一式二份函送本會,於計畫申請截止日期前函送本會(以發文日期為主)。

- 1. 芬方學者應依芬蘭科學院(AKA)規定提出計畫申請。

五、注意事項:

- 1. 本項臺芬人員交流計畫需由計畫主持人自行尋求合作對象,在雙方提出計 書書前,應經過詳細溝通及討論合作主題及內容。
- 2. 以下任一情況的申請案得不受理:
 - (1) 只有單方提出計畫申請書;
 - (2) 超過規定之申請截止日、未依作業程序規定提出;
 - (3) 申請資料不全(如未提供臺芬交流計畫英文申請表、雙方參與訪問的 研究人員履歷等)。
- 3. 獲得本項計畫補助案不列入本會專題研究計畫之件數額度內;惟,臺芬雙 方相同之合作團隊在同一執行年度內僅能獲得本方案一件計畫補助。
- 4. 本次公告主要對計畫申請規定提出說明,有關獲得補助計畫之經費暫付原則與方式、補助項目變更、經費結報及報告繳交等事宜,請依核定公文、核定清單內容並參考本會「補助雙邊協議下科技合作交流及活動計畫作業要點」之規定辦理。
- 5. 年度所需經費如未獲立法院審議通過或經部分刪減,本會得依審議結果調減補助經費,並按預算法第五十四條規定辦理。

With this form, Taiwanese applicants can apply for exchange projects under the framework of the NSTC-AKA bilateral cooperation programme.

Proposals must be **written in English** jointly by the PI in Finland and the PI in Taiwan. The title and names of the Finnish and Taiwanese PI's should be identical. Project description, methodology, work packages, etc. in the research proposal submitted by the Finnish and Taiwanese PI should be consistent with each other.

The applicant is required to submit their proposals to their applicant institutions, which shall review and approve their proposals before submitting them to NSTC. Applications with missing documentation or failing to meet any of the requirements will not be accepted if the applicant institution fails to submit the required documentations or make relevant rectifications within the given deadline.

NSTC and AKA will check whether the proposals have been submitted both in Finland and Taiwan and inform each other of the eligibility. Lack of submission of the application to one of the parties will cause the application to be considered ineligible.

For research projects involving human experimentations or the collection of human specimens/embryo/stem cells, the application must enclose approval documentation from the pertinent medical ethics committee or joint institutional review board. For projects involving gene recombination, Biosafety Committee approval documents to conduct gene recombination experiments must be enclosed with the application. For projects involving gene transgenic field trials, approval documents from the competent authorities must be enclosed with the application. For projects involving animal experimentation, approval documents from the Laboratory Animal Administrative Committee must be enclosed with the application: for projects involving grade two infectious biological materials or higher, approval documents from relevant agencies must be enclosed with the application. If the required approval documentation cannot be submitted along with the application, applicants shall submit the substantiating documents that have already been submitted along with the missing documents within six months.
